## **Pole Position Raceway Holds DUI Public Service Message Event on St. Patrick's Day March 17**

***-Organizations Partner to Host Real-Time Experiment Showing Dangers of Drinking and Driving-***

**LAS VEGAS – (March 11, 2014) –** [Pole Position Raceway](#), in partnership with the [Nevada Highway Patrol](#) (NHP) and [Sudden Impact Auto Body](#), will hold its DUI Public Service Message event 1 – 3 p.m. Monday, March 17th at the high-performance indoor kart track at Pole Position Raceway. Located across the street from the Palms Towers at 4175 S. Arville, the event is designed to graphically illustrate the effects of drinking and driving to bring awareness to the dangers behind mixing alcohol with operating machinery on the St. Patrick's Day holiday.

“This event is an important one for us as we strive to show the dangers and ramifications of drinking and getting behind the wheel,” said Brad Mark, C.O.O. of Pole Position Raceway. “Our goal is to bring awareness to this dangerous issue on a day where many people partake in St. Patrick's Day festivities, in partnership with other great organizations who are passionate, just as we are at Pole Position.”

The three organizations have teamed up to demonstrate the real-time journey of how alcohol impacts reaction time and impairs judgment. Angelique Gorges and Crystal Thurman have volunteered to serve as crash test dummies as they race during the special event. Beginning at 1 p.m., the women will drive intermittently as they consume alcohol between the seven to 10 minute races. Then, NHP will use a breathalyzer device to track blood alcohol content and lap times will be measured electronically with a high-tech timing and scoring system to show a direct correlation. The experiment will be held on a private closed course, separate from the public.

“Our passion to educate motorists on the risks of drunk driving and to better serve the Las Vegas community aligns with our mission to keep Nevada highways safe by reducing injuries and fatalities due to alcohol impairment,” said Jeremie Elliott, public information officer with NHP.

In addition, volunteers from Sudden Impact Auto Body, offering automotive and collision repair services in Southern Nevada, will join in on the message to create awareness by demonstrating

a vehicle after a severe collision, serving as visual aid of the dangers caused by alcohol-impaired driving.

"We are very proud to team up with these two organizations to bring awareness of the devastation and emptiness that results of drinking and driving. Being in an accident is one thing but being involved in a collision while under the influence is absolutely preventable.
