## A. **OVERVIEW:**

The Nevada Silver Alert Plan establishes a formal means of exchanging information between allied law enforcement and public safety agencies, radio, television and cable broadcasters and state and private entities to facilitate the safe return of Missing Endangered Older Persons.

# B. **PURPOSE:**

The Nevada Department of Public Safety (DPS) is committed to work in cooperation with all law enforcement agencies and the Nevada Broadcaster's Association to provide a coordinated and rapid response to instances of Missing Endangered Older Persons within the State of Nevada.

DPS currently is the contact agency for missing adults for the Federal Bureau of Investigation's National Crime Information Center. (SB 245 from Nevada's 2011 Legislative session requires DPS to administer the State's program).

# C. POLICY:

- a. Pursuant to NAC 427A.515, before a law enforcement agency may activate the Silver Alert System, the agency must determine whether the Silver Alert requirements have been met.
- b. NAC 427A.525 states "The Department will maintain on its Internet website a form for use by a law enforcement agency to determine whether to activate the System and to notify the Department that the law enforcement agency is activating the System.

## D. **DEFINITIONS:**

Elderly person means a person who is 60 years of age or older. (NRS 427A.122)

## E. STANDARD OPERATING PROCEDURE:

- 1. DPS responsibilities:
  - a. Partner with the Nevada Department of Transportation (NDOT), local law enforcement agencies, media outlets and other public/private organizations to assist in the search for missing endangered older persons.
  - b. Develop a plan for carrying out the Silver Alert System which includes the components of the system.
  - c. Oversee the system.
  - d. Supervise and evaluate any training associated with the system.
  - e. Monitor, review, and evaluate activations of the system to determine whether such activations complied with the statutory criteria.
  - f. Conduct periodic tests of the system.
  - g. Adopt regulations for activating/de-activating the system.
  - h. Develop forms for local law enforcement agencies to activate/deactivate the system.
  - i. *If a vehicle was not involved in the disappearance of the missing endangered older person*, initiate a radio broadcast of the information about the missing endangered older person and re-broadcast every 4 hours until the time limit expires (48 hours), an extension is granted by the DPS Director/Designee, or the alert is canceled by the requesting law enforcement agency. Otherwise, there is no radio broadcast.
  - j. *If a vehicle was involved in the disappearance of the missing endangered older person*, notify media outlets, NDOT, and other public/private organizations that the system has been activated. Otherwise, the requesting agency is responsible for media and public/private agency notification.
  - k. Director/Designee and/or the Records, Communications and Compliance Division Administrator, may grant a time extension beyond the 48 hours if the local law enforcement agency that requested activation provides additional information which assist in locating the missing endangered older person.

### 2. Criteria

- a. There are five (5) standards that must be met for a Nevada Silver Alert activation:
- 1) Is the person 60 years of age or older and whose whereabouts are unknown: **AND**

- 2) Is diagnosed with a medical or mental condition that places the the older citizen in danger of serious physical harm or death; **OR**, who is missing under suspicious or unexplained circumstances that place the person in danger of serious physical harm or death.
- 3) An investigation by the local law enforcement agency has taken place verifying that the disappearance is due to his/her impaired mental condition, and alternative reasons for the older person's disappearance have been ruled out: **AND**
- 4) The Silver Alert activation request has been made within 72 hours of the older citizen's disappearance: **AND**
- 5) There is sufficient information available to disseminate to the public that could assist in locating the older citizen.

#### 3. Activation

- a. PSD will receive a completed DPS Silver Alert Request form.
  - 1) Form will be faxed to the local DPS Communications Center by the requesting law enforcement agency.
  - 2) Alert will be valid for a period of 48 hours.
  - 3) The missing older citizen must be listed into N.C.I.C.
- b. PSD will create a Spillman incident using Silver Alert PS nature
  - 1) PSD will scan the Silver Alert Request form and attach it to the incident.
- c. PSD will notify the following partners and participants of the activation for voluntary dissemination of information within the advisory to:
  - 1) Nevada Department of Transportation (NDOT).
  - 2) Nevada Broadcasters Association and other established media.
  - 3) Other locally established Advisory Partners, Groups or Organizations.
  - 4) Other DPS Communications Center, if the information indicates the possibility of the missing older citizen entering their geographical area.
- d. PSD will broadcast an Attempt To Locate for the missing older citizen. PSD will repeat this broadcast every four (4) hours.

- e. PSD will contact the reporting agency after 12, 18, and 23 hours.
  - 1) An extension must be requested prior to or during the 23-hour reminder from the Communications Center.
  - 2) An extension, for an additional 48 hours, will be considered by the Director of the Department or his or her designee if the law enforcement agency is able to provide new facts or information that would result in locating the older citizen.

## 4. Deactivation

- a. PSD will cancel the Silver Alert when notified by the reporting agency OR after 48 hours.
- b. PSD will broadcast information regarding the Silver Alert cancellation.
- c. PSD will update the Spillman Silver Alert PS incident with all pertinent information regarding the cancellation.
  - d. PSD cancel the Silver Alert with the partners and participants of the activation.
  - e. PSD will scan all related documents and attach to the incident. PSD will send the Communication Center Manager an email with the long-term CAD number.
